BOARD OF DIRECTORS MEETING

The annual meeting of the Board of Directors was held on July 26th. The following Officers were elected:

(A co-chair was determined as necessary to split the responsibilities of issuing membership cards and collecting dues along with responding to website inquiries, compiling the membership list in coordination with the Secretary's mailing list, and collection of member emergency contact information.)

- The Club also assigned Board Members and non-Board members to additional appointed positions.

IRV TESMER AND DAVE PRZEPIORA


As we all know, Irv and Dave published their book, *Postal History of Buffalo, New York 1805-1905* late last year. The Club sent a copy to The American Philatelic Research Library for their holdings. The library sent a letter to the Club acknowledging receipt, and the call number for the book was published in the Second Quarter *APRL Review* which means that it is available for loan.

If you opened your August 2019 *American Philatelist,* there was an additional surprise. On page 752 was a review of Irv and Dave's book! A review in the *APS* was unexpected, but well deserved.

The review was well written praising Irv and Dave for the organization and selection of covers for the respective periods covered in the book. The layout of the book together with the quality of the illustrated covers (all in color) were commended. The Club, thanks to Bob Meegan and Alan Davis, were able to assist in the editing and production of the book.

Interestingly, the reviewer believes the book serves as a model for other clubs and societies to use when studying postal history of their respective areas.

SEPTEMBER PRESENTATION

On September 13th, Editor Al will give a presentation on U.S. post office seals. Post office seals or official seals are listed by the prefix OX in the Scott Catalogue. They are issued by post offices around the world, including the U.S. where they began as seals for large registered packages. Later they were used by dead letter offices to seal undeliverable mail which was opened.



Most sealed covers are tattered examples as they were opened under extreme conditions. They are usually damaged and because they were used to seal envelopes the seal is evident on both sides of the cover. The above example is OX39.

The presentation will show examples of the seals themselves and postally used examples. Hope to see everyone there!
