INTERESTING COVER



If you examine the above cover carefully, it is franked with a US stamp (Scott 301) and Canada stamp (Scott 90). How is this possible?

The cover was mailed from Buffalo on September 6, 1903, arriving in Toronto on September 7. Apparently, Ms. Harbinson was not at the Toronto address. Someone knew that she was in Buffalo, crossed out the Toronto address and wrote in the Buffalo address and mailed back on September 12, arriving back in Buffalo on September 13.

Why the Canada stamp? Per Universal Postal Union Treaty rates, the forwarding of mail cross-border required additional postage. A 2 cent Canada stamp was used to send the cover to Buffalo. Thus, a cover with 2 different country stamps.



FOURTH BUREAU ISSUE

The centennial of the 1922 series of US stamps known as the Fourth Bureau Issue is underway. It is the fourth set of ordinary stamps printed by the Bureau of Engraving and Printing (BEP). The series began with the 11 cent Rutherford B. Hayes stamp (Scott 563) and was followed by 20 other stamps ranging in value from ½ cent to \$5. This series would be the workhorse of the post office until the 1938 Presidential series was released (the Prexies).

The Fourth Bureau issues present a unique opportunity to explore. The varieties of each issue are unique and represent the technological advances in printing stamps. During this period the BEP was developing highspeed rotary presses replacing the cumbersome flat press. Of course, there is also the postal history. It would be interesting to know if a Club member specializes in this area. Let the Club know! We're sure that specialized material from this issue would be an interesting presentation.



2023 POSTAL RATE INCREASE

The USPS will raise its rates on January 22, 2023 particularly first-class mail which will increase from 60 cents to 63 cents. There is no increase for the rate covering each addition ounce on first-class mail.

CTO STAMPS

One of the commonly misunderstood terms in philately is "used." All philatelic dictionaries define "used" as a stamp which has been postmarked or canceled and has passed through the mail stream. "Canceled To Order" (CTO) refers to a stamp that also has been postmarked or canceled but has <u>not</u> passed through the mail steam.

Beware that some sellers take liberty with the distinction between the two terms offering stamps that are used, but in fact are CTO.

The following stamps from the Soviet Union were described as used. Upon receipt, all the stamps had their original gum.



In addition, CTO stamps have postmarks that are distinctive and are uniform on all stamps. Note that the above three stamps have postmarks located in the corners of the stamps. Postal agencies intentionally postmarked sheets of stamps which are sold to the general public, particularly collectors at less than face value.

CTO's are known among those countries that have large stamp programs and have small postal usage. However, it is a cheap source if you are looking to fill spaces in your album!
